Standard Specification for Technical Grade Ethylene Dichloride¹

This standard is issued under the fixed designation D 5960; the number immediately following the designation indicates the year of original adoption or, in the case of revision, the year of last revision. A number in parentheses indicates the year of last reapproval. A superscript epsilon (ϵ) indicates an editorial change since the last revision or reapproval.

1. Scope

1.1 This specification covers technical grade ethylene dichloride.

3.1 Technical grade ethylene dichloride shall conform to the requirements prescribed in Table 1.

4.1 Package and label industrial or commercial quantities in accordance with DOT regulations 49 CFR 100 to 199, and in accordance with state and local regulations, and with OSHA regulations found in 29 CFR 1910.1200.
