INTRODUCTION to Amendment

This amendment adds an important update considered during the development of the base publication, IEC 60794-2-21:2019.

As regards minimum multimode fibre bandwidth requirements (Table 3), this amendment provides new guidance as concerns effective modal bandwidth in the 840 nm to 953 nm wavelength range which was not considered mature enough during the development of IEC 60794-2-21:2019.

It is expected that the content of this amendment will be incorporated into the future edition 4 of IEC 60794-2-21.
