Replace the existing paragraph, excluding the note, with the following new paragraph:

The float-free capsule shall include a homing transmitter operating on 121,5 MHz, complying with IEC 61097-2, except that a Morse letter "V" (•••-) shall be inserted with a repetition period varying between 47,5 s and 52,5 s, with a dot length (one unit) equal to 115 ms ± 5 %, see Figure 1.

Delete, in the existing note, the last sentence.
