- for trunking with a width equal to or greater than 62,5 mm, two fixings are used as shown in Figure 103 b).

Replace, in the sixth paragraph, "class 5, Table 3" with "Table 3 – class 5".

Replace the title of Figure 103 b) with "Figure 103 b) Fixing distances for cable support test for trunking with a width equal to or greater than 62,5 mm".
