1 Scope

Add, at the end of the scope, the following new paragraph:

When reference is made to a winding wire according to the present standard, the following information is given in the description:

- reference to IEC specification;
- nominal conductor dimensions in millimetres (width × thickness);
- nominal increase in dimensions due to paper.

EXAMPLE: IEC 60317-27 – 4,00 × 1,00 + 0,20
