The instructions shall state that the appliance is to be connected to the water mains using new hose-sets and that old hose-sets should not be reused.

Drops of undiluted rinsing agent, as specified in annex AA, are applied to the external surface of the parts from which rinsing agent could leak if a seal fails.

After the test, there shall be no rinsing agent on the insulation of internal wiring, if deterioration of the insulation could result in a hazard.

NOTE 2 The influence of opening and closing the door is taken into account.

NOTE 3 Leakage of rinsing agent onto porous material is taken into account if this material is in contact with internal wiring.
