The text of document 86A/676/FDIS, future edition 1 of IEC 60793-1-47, prepared by SC 86A, Fibres and cables, of IEC TC 86, Fibre optics, was submitted to the IEC-CENELEC parallel vote and was approved by CENELEC as EN 60793-1-47 on 2001-07-03.

This European Standard supersedes subclause 4.29 (test method 318) of EN 188000:1992.

The following dates were fixed:

- latest date by which the EN has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2002-09-01
- latest date by which the national standards conflicting with the EN have to be withdrawn (dow) 2004-07-01

Annexes designated "normative" are part of the body of the standard.

In this standard, annex ZA is normative.

Annex ZA has been added by CENELEC.

Compared to IEC 60793-1:1989 and IEC 60793-2:1992, IEC/SC 86A has adopted a revised structure of the new IEC 60793 series: The individual measurement methods and test procedures for optical fibres are published as "Part 1-XX"; the product standards are published as "Part 2-XX".
