Foreword

This amendment to the European Standard EN 60730-2-1:1997 was prepared by the Technical Committee CENELEC TC 72, Automatic controls for household use.

The text of the draft was submitted to the Unique Acceptance Procedure and was approved by CENELEC as amendment A11 to EN 60730-2-1:1997 on 2004-12-01.

This amendment was prepared in order to delete requirements which are to be included in Part 1 or in a separate Part 2. EN 60730-2-1:1997 will be withdrawn at the latest date of withdrawal of the last Part 2 for which it is applicable, i.e. 2009-03-01 which aligns with the dow of EN 60730-2-2:2002.

The following dates were fixed:

- latest date by which the amendment has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2005-12-01
- latest date by which the national standards conflicting with the amendment have to be withdrawn (dow) 2009-03-01
