The present document specifies the signalling protocol for use at the Q reference point in support of the Do Not Disturb (DND) and Do Not Disturb Override (DNDO) supplementary services.

The protocol defined in the present document forms part of the PSS1 protocol (informally known as QSIG).

The present document endorses an International Standard, ISO/IEC 14844.
