### Optics and optical instruments — Microscopes — Slides — Part 1: Dimensions, optical properties and marking

#### Introduction

This part of ISO 8037 lays down dimensions and specifies optical quality requirements in order, on the one hand, to solve the problem of storing slide preparations and, on the other hand, to guarantee the quality of observation. The data given in this part of ISO 8037 are applicable to most products in use and have been adapted to take into account the relevant national standards in force.

This part of ISO 8037 contains requirements for dimensions. thickness and optical properties, whereas quality requirements and test methods related to the material will be dealt with in a standards.ite future part of ISO 8037.

Microscope slides form part of the illuminating system the task of which it is to illuminate the specimens, sometimes at very 1:1986 large condenser apertures and often so as to form the additionals/sist/2 image of a diaphragm — the so-called "field diaphragm" 465/iin-8037-1-1986 the specimen. When a specimen is being prepared, it is often completely left to the discretion of the user to decide which method of microscopy (bright field, dark field, phase contrast, interference contrast) will be required for observation. Microscope slides and condensers (parts of the illuminating optical system) should, therefore, be suitable for a specimen to be illuminated and observed whatever the method chosen. In this context, it is important to keep to a certain refractive index and a certain thickness of the microscope slide, which together influence the quality of the image of the field diaphragm and the working distance between condenser and microscope slide.

#### 1 Scope and field of application

This part of ISO 8037 specifies requirements for dimensions, thickness, optical properties and tolerances for microscope slides used for transmitted light microscopy in the visible spectral range<sup>1)</sup>.


NOTE - This part of ISO 8037 does not cover requirements for suitability for fluorescence microscopy.

#### 3.1 Dimensions (see the figure)

#### 3.1.1 Length

The length, *l*, for microscope slides shall be as given in the table.

#### 3.1.2 Width

The width, b, for microscope slides shall be as given in the table.

#### 3.1.3 Thickness

The thickness, s, for microscope slides shall be

$$s = 1,1^{+0,1}_{-0,2} \text{mm}$$

NOTE — Thicker and thinner slides are available. Highest optical quality, particularly with large aperture condensers, may not be obtained with these thicknesses.

#### 3.2 Optical properties

The optical properties of microscope slides shall be as follows:

Principal refractive index:  $n_e = 1,53 \pm 0,02$ 

NOTE — The principal refractive index,  $n_{\rm e}$ , is the refractive index of light at the green mercury e-line ( $\lambda_{\rm e}=546,07$  nm; see ISO 7944). This wavelength is close to the maximum sensitivity of the eye and has been used as the principal wavelength of optical computation for some time.

#### 4 Marking

The packaging of microscope slides conforming to this part of ISO 8037 shall be marked with the following information:

- a) the dimensions or designation, as given in the table;
- b) the average number of slides per package;
- c) the manufacturer's or supplier's name or mark, and country of origin;
- d) a statement that the slides comply with the requirements laid down in this part of ISO 8037.
