Amendment A 1 to EN 1854

This amendment A 1 to EN 1854 specifies the additional requirements for pressure sensing devices supplied with an assembled electrical plug connector.

6.4.5 Pressure sensing devices supplied with an assembled electrical plug connector in accordance with ISO 6952:1994 or ISO 4400:1994 shall have connections to the following pins and to earth:

- Pin 4 (e) earth contact
- Pin 1 NC, normally closed
- Pin 2 NO, normally open
- Pin 3 COM, common
