Foreword

This amendment was prepared in order to make EN 60730-2-1 not applicable for controls covered by this standard. EN 60730-2-1:1997 will be withdrawn at the latest date of withdrawal of the last Part 2 for which it is applicable (i.e. 2009-03-01 applicable to EN 60730-2-2:2002).
