### 16 Creepage distances and clearances

*Replace existing subclauses 16.2 and 16.3 by the following:*

**16.2** The clearance between live parts of the lampholder and accessible metal parts of the cap shall not be less than 1,5 mm.

NOTE For Japan, the minimum distance is 1,7 mm

**16.3** For metal retention springs which are not covered, a minimum clearance of 3 mm to the mounting surface is required.
