It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

7 Marking and instructions

Add the following subclause:

7.12.1 Addition:

The installation instructions for **fixed towel rails** shall include the substance of the following:

WARNING: In order to avoid a hazard for very young children, this appliance should be installed so that the lowest heated rail is at least 600 mm above the floor.
