INTRODUCTION

Replace the fifth paragraph by the following:

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

1 Scope

Replace the second paragraph by the following:

This International Standard deals with the safety of electric dishwashers for household and similar purposes that are intended for washing and rinsing dishes, cutlery and other utensils, their **rated voltage** being not more than 250 V for single-phase appliances and 480 V for other appliances.

Appliances intended for normal household and similar use and that may also be used by laymen in shops, in light industry and on farms, are within the scope of this standard. However, if the appliance is intended to be used professionally for washing and rinsing dishes and cutlery and other utensils that are used for commercial purposes, the appliance is not considered to be for household and similar use only.

Replace the two dashed items in the existing third paragraph by the following:

- persons (including children) whose
 - physical, sensory or mental capabilities; or
 - lack of experience and knowledgeprevents them from using the appliance safely without supervision or instruction;
- children playing with the appliance.

7.6 *Delete the addition.*

7.12 *Replace the last paragraph of the addition by the following:*

The instructions shall include the substance of the following:

This appliance is intended to be used in household and similar applications such as:

- staff kitchen areas in shops, offices and other working environments;
- farm houses;
- by clients in hotels, motels and other residential type environments;
- bed and breakfast type environments.

NOTE 101 If the manufacturer wants to limit the use of the appliance to less than the above, this must be clearly stated in the instructions.

7.12.1 *Replace the text of the addition by the following:*

For dishwashers having ventilation openings in the base, the instructions shall state that the openings must not be obstructed by a carpet.

7.14 *Delete the addition.*

7.101 *Delete the subclause.*

19 Abnormal operation

19.101 Add the following dashed item to Note 6:

- the failure of door interlocks is covered by 24.1.4.

22 Construction

22.103 In Note 1, replace “6.86 of ISO 4046” by “4.215 of ISO 4046-4”.

24 Components

24.1.4 Add the following:

The number of cycles of operation for door interlocks is 30 000.
