1 Scope

This standard specifies the properties of silicone rubber (VMQ/PVMQ) ¹⁾, with high tear strength, hardness 50 IRHD, for aerospace applications.

2 Normative references

3 Application of the material

The suitability of the material for a specific application shall be determined by complementary tests carried out on the finished product as the properties specified in this standard are obtained from standard test specimens.

3.1 Typical use

For application as ozone and weather resistant rubber with good thermal properties and high tear strength.

NOTE : The ozone resistance test is not required.

3.2 Temperature range

- Continuous service : from - 55 °C to + 200 °C
- Intermittent service : from - 55 °C to + 225 °C

4 Properties

See tables 1 and 2.

For qualification, all tests shall be performed.

For batch acceptance, the tests identified in tables 1 and 2 shall be performed.
