Foreword

When discussing the comments received during the voting procedure for prEN 60335-2-75 at the Balsthal meeting of CENELEC TC 61 in June 2004, the Italian national committee was asked to prepare a firm proposal for an amendment to be submitted to the Unique Acceptance Procedure. This proposal, document CENELEC/TC 61/IT0264/NP, was discussed during the Milan meeting of CENELEC TC 61 in November 2004 and was accepted for circulation as a draft amendment.

The draft was circulated in April 2005 and was approved by CENELEC as amendment A11 to EN 60335-2-75:2004 on 2005-12-06.

The following dates are applicable:

- latest date by which the amendment has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2006-12-01
- date on which national standards conflicting with the amendment have to be withdrawn (dow) 2006-12-01

This amendment supplements or modifies the corresponding clauses of EN 60335-2-75:2004.

There are no special national conditions causing a deviation from this amendment.
