This amendment has been prepared by IEC technical committee 61: Safety of household and similar electrical appliances.

## 3 Definitions

**3.1.9** Add the following dashed item to the third paragraph:

 15 °C ± 5 °C for appliances without heating elements and intended for connection to the cold water supply only.

Replace Note 101 by the following:

NOTE 101 For impeller type washing machines, if the textile material does not move properly during operation,

- the quantity of textile material may be reduced until the maximum power input of the motor is attained, or
- a textile material comprising pre-washed double-hemmed cotton sheets, having dimensions of approximately 90 cm x 90 cm and a mass between 90 g/m<sup>2</sup> and 110 g/m<sup>2</sup> in the dry condition, may be used.

## 7 Marking

**7.1** Add the following:

Appliances not intended for connection to the hot water supply and not provided with heating elements, shall be marked with the substance of the following:

CAUTION: Do not connect to the hot water supply.

### **19** Abnormal operation

**19.1** Addition:

Appliances not intended for connection to the hot water supply and not provided with heating elements are also subjected to the test of 19.102.

**19.13** Replace the second paragraph of the addition by the following:

During the tests of 19.101 and 19.102, the temperature of windings shall not exceed the values specified in Table 8.

Add the following new subclause:

**19.102** Appliances not intended for connection to the hot water supply and not provided with heating elements are operated under the conditions of Clause 11, except that they are supplied at **rated voltage** and filled with water at a temperature of 65  $^{\circ}$ C ± 5  $^{\circ}$ C.

## 20 Stability and mechanical hazards

Replace the requirement in 20.103 of Amendment 1 by the following:

For washing machines of the drum type that are loaded from the front, the door shall be interlocked so that the appliance can only be operated when the door is in the closed position.
