Scope 1

This part of ISO 9374 specifies generally the information to be provided by the purchaser and the manufacturer so that the most suitable crane can be provided for the duty requirements and service R conditions.

3 Information to be provided by purchaser with enquiry or order

The information to be provided by the purchaser shall include, as appropriate for the type of crane concerned:

a) the identity of the parties concerned with addresses, telephone numbers and persons who may be contacted;

 - crane concerned;
 - e) any dimensional or clearance restrictions:
 - f) any other special requirements of the purchaser.

Information to be provided by 4 manufacturer

The information to be provided by the manufacturer shall include, as appropriate for the type of crane concerned:

- a) technical information and test certificates for the crane to facilitate its installation and/or use in accordance with ISO 7363;
- b) an instruction manual which shall include details of routine servicing, inspection and maintenance of the crane;
- c) dimensions, masses and any other details.
