Words in **bold** in the text are defined in Clause 3. When a definition concerns an adjective, the adjective and the associated noun are also in bold.

With amendment 1, this Part 2 is established on the basis of the fourth edition (2006) of IEC 60745-1, Hand-held motor-operated electric tools – Safety – Part 1: General requirements.
