1 Scope

This part of ISO 9393 specifies the test parameters and conditions for hydrostatic-pressure tests on valves made of the following thermoplastic materials:

— polyethylene (PE) iTeh STANDARD PREVIEW

PE 100, PE 80, as defined in ISO 12162 and ards.iteh.ai)

polypropylene (PP)

unplasticized poly(vinyl chloride) (PVC-U)

material having an MRS equal to or greater than 25 MPa as defined in ISO 12162 (PVC-UH) (see ISO 4422-3)

poly(vinylidene fluoride) (PVDF) homopolymer as defined in ISO 12162

The tests cover the following aspects:

- the material used for manufacturing valves;
- the pressurized valve components;
- the complete valve.

3 Material test

- **3.1** The material shall be tested in accordance with the conditions and requirements given in ISO/TR 9080 or equivalent and classified in accordance with ISO 12162.
- 3.2 It is not necessary to retest material which has already been tested by the material supplier.

4 Shell test

4.1 Test conditions

The test specimen described in 5.2 of ISO 9393-1:1994 shall be subjected to the applicable test conditions given in table 1.

4.2 Requirements

The test specimen shall be considered satisfactory if no leakage from the valve is noted, and no rupture or other visible failure occurs during the test period. The test specimen be regarded as unsatisfactory if the valve body bursts before the end of the test period.

If a pipe or a connection fails, the test shall be considered null and void and shall be repeated using a different specimen.

5 Long-term behaviour test on the complete valve

5.1 Test conditions

The test specimen described in 5.3 of ISO 9393-1:1994 shall be subjected to the applicable test conditions given in table 2.

- σ_t is the induced stress under the test conditions 659125a9/iso-9393-2-1997
- $\sigma_{\rm S}$ is the design stress in megapascals.

For diaphragm valves, the test pressure shall be $1.5 \times PN$ bar for all materials except for PVC-U and PVC-UH ($1.3 \times PN$ bar) and PVDF ($1.45 \times PN$ bar).

5.2 Requirements

The test specimen shall be considered satisfactory if no leakage from the valve is noted, and no rupture or other visible failure occurs during the test period. The test specimen shall be regarded as unsatisfactory if the valve assembly bursts before the end of the test period.

If a pipe or a connection fails, the test shall be considered null and void and shall be repeated using a different specimen.

6 Seat and packing tests

6.1 Test conditions

The test conditions¹⁾ shall be the same for all the different valve materials. Test specimens (complete valves) shall be subjected to the tests described in 7.4.1 and 7.4.2 of ISO 9393-1:1994 using the test conditions given in table 3, as applicable.

¹⁾ The general criteria for seat and packing tests are taken from ISO 5208:1993, *Industrial valves* — *Pressure testing of valves*.

6.2 Requirements

The test specimen shall be considered satisfactory if no leakage occurs through the valve seat and packing during the test period.
