INTRODUCTION

SIST EN 60335-2-54:2003/A2:2007

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

Replace the two dashed items in the third paragraph by the following:

- persons (including children) whose
 - physical, sensory or mental capabilities; or
 - lack of experience and knowledge

prevents them from using the appliance safely without supervision or instruction;

children playing with the appliance.

Add the following new definition:

3.101

pressurised appliance

appliance in which steam is produced in a boiler at a pressure exceeding 50 kPa and in which the pressure does not drop to atmospheric pressure when the steam is not supplied

NOTE The boiler may be incorporated in the appliance or connected to the appliance by a hose.

Compliance is also checked by holding appliances carried on the operator's body in the most unfavourable position at a height of 1 m and dropping them onto a concrete floor.

The test is carried out three times.

22.7 Replacement:

Make the following changes:

- in the first paragraph of the requirement, replace "Appliances having a pressurised container" by "Pressurised appliances";
- in the third sentence of the second paragraph of the test specification, replace "increase by more than" by "exceed";
- in the second paragraph of the test specification, replace "container" by "boiler" in two places;
- in the third paragraph of the test specification, replace the first sentence by the following:

Steam cleaners incorporating hoses and having 20 device) regulating the steam supply are operated as specified in Glause 11, but with all pressure regulating devices operating during the test of Clause 11 rendered inoperative.en-60335-2-54-2003-a2-2007

- in the third sentence of the third paragraph of the test specification, replace "container" by "boiler";
- in the fourth paragraph of the test specification, replace the second sentence by the following:

The pressure shall not exceed three times the pressure measured during the test of Clause 11.

22.102 Replace the text of this subclause by "Void".

22.103 In the first paragraph of the requirement, replace "Pressurised appliances" by "**Pressurised appliances**".

In the second paragraph of the requirement, replace "pressurised container" by "boiler".

22.105 In the requirement, replace "pressurised container" by "boiler" and "container" by "boiler".

In the test specification, replace "containers" by "boilers".
