Foreword

This European Standard has been prepared by the European Association of Aerospace Manufacturers (AECMA).

After inquiries and votes carried out in accordance with the rules of this Association, this Standard has received the approval of the National Associations and the Official Services of the member countries of AECMA, prior to its presentation to CEN.

This European Standard shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by May 2002, and conflicting national standards shall be withdrawn at the latest by May 2002.

1 Scope

This standard specifies a method of checking the resistance of optical connection elements (including permanent connections) and fibre optic couplers to fluids and lubricants.

It shall be used together with EN 2591-100.

3 Preparation of specimens

3.1 Specimens shall be fitted with normal accessories and terminated in accordance with the product standard. Cavities with unterminated contacts shall have filler plugs fitted (where applicable).

3.2 Unless otherwise indicated in the technical specification, the following details shall be specified :

See EN 2591-315 (if applicable) plus:

- type and length of cable/fibre;
- maximum value of insertion loss (EN 2591-601).

After withdrawal from the liquid, the specimen shall be engaged and disengaged. Full engagement shall be achieved without the use of tools.

5.2.2 to 5.2.6

5.2.7 Optical faces shall be cleaned as defined in EN 2591-100.

5.3 Final measurements and requirements (if applicable)

- EN 2591-601 – Insertion loss;
- EN 2591-6101 – Visual examination: discolouration is permitted, except on the optical faces;
- EN 2591-408 – Mating and unmating forces;
- EN 2591-409 – Contact retention in insert.
