
Foreword

1 Scope

This standard specifies the required characteristics for three-pole, temperature compensated circuit breakers, rated currents from 20 A to 50 A, UNC thread terminals, for use in aircraft electrical systems, at temperatures between – 55 °C and 90 °C and at a maximum altitude of Z = 15 000 m.

It shall be used together with EN 2665-001.

These circuit breakers are intended for use in aircraft with electrical supplies in accordance with EN 2282.

4 Required characteristics

4.1 Short-circuit performance

Test current: 1 500 A prospective, $0,8 \leq \cos \varphi < 1$

Number of CO/OCO tests: 1 CO + 2 OCO + 1 CO + 2 OCO

4.2 Dimensions, mounting, electrical connections

Dimensions and tolerances are in millimetres.




Figure 1: Circuit breaker




Figure 2: Panel cut-out
(panel thickness 1,5 to 3)




Figure 3: Electrical connection




Protection: black zinc dichromate





Figure 6: Attachment nut
