This Amendment EN 736-3:1999/A1:2001 to the EN 736-3:1999 has been prepared by Technical Committee CEN/TC 69 "Industrial valves", the secretariat of which is held by AFNOR.

This Amendment to the European Standard EN 736-3:1999 shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by March 2002, and conflicting national standards shall be withdrawn at the latest by March 2002.

This European Standard has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association. This European Standard is considered to be a supporting standard to those application and product standards which in themselves support an essential safety requirement of a New Approach Directive and which make reference to this European Standard.

3.3.7**anti-blow out design**

Replace by :

"valve design which ensures that the shaft or stem cannot be blown out of the shell when the valve is under pressure

— by disassembly of any external part or,

— by failure of the connection between obturator and shaft or stem even when external parts are removed."

NOTE External parts are parts which are not included in the bare shaft valve (bracket, lever, actuator...)
