This bilingual version (2005-04) replaces the English version.

This part 2 is to be used in conjunction with the latest edition of IEC 60335-1 and its amendments. It was established on the basis of the fourth edition (2001) of that standard.

NOTE 1 When "Part 1" is mentioned in this standard, it refers to IEC 60335-1.

This part 2 supplements or modifies the corresponding clauses in IEC 60335-1, so as to convert that publication into the IEC standard: Safety requirements for fixed electric immersion heaters.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification", or "replacement", the relevant text in Part 1 is to be adapted accordingly.

NOTE 2 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.

NOTE 3 The following print types are used:

- requirements: in roman type;
- test specifications; in italic type; ANDARD PREVIEW
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3. When a definition concerns an adjective, the adjective and the associated noun are also in bold.

NOTE The attention of National Committees is drawn to the fact that equipment manufacturers and testing organizations may need a transitional period following publication of a new, amended or revised IEC publication in which to make products in accordance with the new requirements and to equip themselves for conducting new or revised tests.

It is the recommendation of the committee that the content of the amendment 2 be adopted for implementation nationally not earlier than 12 months or later than 36 months from the date of publication.

#### INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules may differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another part 2 of IEC 60335, the relevant part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

### HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

#### Part 2-73: Particular requirements for fixed immersion heaters

#### 1 Scope

2

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of **fixed electric immersion heaters** for household and similar purposes that are intended for installation in a water tank open to the atmosphere for heating water to a temperature below its boiling point. The **rated voltage** is not more than 250 V for single-phase appliances and 480 V for other appliances.

NOTE 101 The water tank may have alternative means for heating water, such as the circulation of hot water supplied from a separate boiler.

NOTE 102 Immersion heaters having a **rated power input** up to 25 kW for incorporation as an alternative heating source in central heating boilers are also within the scope of this standard.

Appliances not intended for normal household use but which nevertheless may be a source of danger to the public, such as appliances intended to be used by laymen in shops, in light industry and on farms, are within the scope of this standard.

As far as is practicable, this standard deals with the common hazards presented by appliances that are encountered by all persons in and around the home. However, in general, it does not take into account 60335-2-732002+AMD1:2006+AMD2:2009 CSV

- persons (including4children) whose 335-2-73-2002 amd 1-2006 amd 2-2009-csv
  - physical, sensory or mental capabilities; or
  - · lack of experience and knowledge

prevents them from using the appliance safely without supervision or instruction;

children playing with the appliance.

NOTE 103 Attention is drawn to the fact that

- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements may be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities and similar authorities.

NOTE 104 This standard does not apply to

- appliances intended exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas);
- heating elements incorporated in appliances such as
  - appliances for heating liquids (IEC 60335-2-15);
  - storage water heaters (IEC 60335-2-21);
  - instantaneous water heaters (IEC 60335-2-35);
- aquarium heaters (IEC 60335-2-55);
- portable immersion heaters (IEC 60335-2-74);
- engine preheaters such as those for cars and buses.

#### 2 Normative references

This clause of Part 1 is applicable.

#### 3 Definitions

This clause of Part 1 is applicable except as follows.

#### 3.1.9 Replacement:

#### normal operation

operation of the appliance after installation in the smallest tank specified, the tank being thermally insulated and filled with water

NOTE 101 Accessible parts of the appliance are not thermally insulated.

#### 4 General requirement

This clause of Part 1 is applicable.

#### 5 General conditions for the tests

#### 6 Classification

This clause of Part 1 is applicable except as follows.

#### **6.1** Addition:

Immersion heaters shall be class I, class II or class III.

#### 7 Marking and instructions

This clause of Part 1 is applicable except as follows.

#### **7.1** *Modification:*

Appliances for multiple supply shall be marked with their **rated power input** for each supply circuit.

#### Addition:

Appliances shall be marked "Do not cover".

#### **7.12.1** Addition:

The installation instructions shall include the substance of the following:

- the type and dimensions of the tank in which the immersion heater can be installed;
- the positioning of the immersion heater within the tank;
- a statement that the installer must check that there is water in the tank before the immersion heater is first switched on;
- a statement that the immersion heater is to be installed only in a system where the heating element is always below water level, such as in a cistern-fed tank, if applicable.

#### 8 Protection against access to live parts

This clause of Part 1 is applicable.

#### 9 Starting of motor-operated appliances

This clause of Part 1 is not applicable.

#### 10 Power input and current

This clause of Part 1 is applicable ANDARD PREVIEW (standards.iteh.ai)

#### 11 Heating

#### **11.7** *Addition:*

Appliances are operated until steady conditions are established. However, the test is terminated after 24 h provided that a thermal control has operated.

This clause of Part 1 is applicable.

#### 14 Transient overvoltages

This clause of Part 1 is applicable.

#### 15 Moisture resistance

This clause of Part 1 is applicable.

#### 16 Leakage current and electric strength

This clause of Part 1 is applicable.

#### 17 Overload protection of transformers and associated circuits

This clause of Part 1 is applicable.

#### 18 Endurance

This clause of Part 1 is not applicable.

#### 19 Abnormal operation

This clause of Part 1 is applicable except as follows.

#### 19.2 Addition:

Appliances are operated with the tank empty, any thermal control that operates during the test of Clause 11 being short-circuited.

NOTE 101 If more than one thermal control operates during the test of Clause 11, they are short-circuited in turn.

The test is not carried out on immersion heaters intended to be installed in a system where the heating element is always below water level, such as in a cistern-fed tank.

### 19.4 Modification: iTeh STANDARD PREVIEW

Appliances are operated with the tank filled with water to at least 10 mm above the highest point of the heating element, or the highest level allowed by the construction.

#### 20 Stability and mechanical hazards

This clause of Part 1 is applicable.

#### 21 Mechanical strength

This clause of Part 1 is applicable.

#### 22 Construction

This clause of Part 1 is applicable except as follows.

**22.101** Appliances shall be supplied with a seal or similar means to ensure that there is no leakage from the tank after installation.

Compliance is checked by inspection during the test of Clause 11.

**22.102** The compartment containing the supply terminals shall be prevented from rotating by more than 180° with respect to the fixed part of the immersion heater.

Compliance is checked by inspection.
