



This part of International Standard IEC 60335 has been prepared by IEC subcommittee 61E: Safety of electrical commercial catering equipment, of IEC technical committee 61: Safety of household and similar electrical appliances.

This sixth edition constitutes a technical revision.

The principal changes in this edition as compared with the fifth edition of IEC 60335-2-39 are as follows (minor changes are not listed):

- addition to definition of portable appliances, atmospheric multi-purpose cooking and rated pressure;
- deletion of equipotential symbol 5021 of IEC 60417 covered by Part 1;
- addition of instructions for multi-purpose cooking pans;
- modification on leakage current permissible for portable class I appliances;
- addition to abnormal test requirements;
- addition to mechanical hazard test for multi-purpose cooking pans
- addition of construction test for multi-purpose cooking pans;
- addition to construction requirements for lids and theirs grips;
- addition to construction requirements for positioning of pressure reliefs;
- addition to construction's fixed appliances which are moved forward and backward for cleaning purposes.

This part 2 is to be used in conjunction with latest edition of IEC 60335-1 and its amendments. It was established on the fifth edition (2010) of that standard.

NOTE 1 When "Part 1" is mentioned in this standard, it refers to IEC 60335-1.

This part 2 supplements or modifies the corresponding clauses in IEC 60335-1, so as to convert that publication into the IEC standard: Safety requirements for commercial electric multi-purpose cooking pans.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text in Part 1 is to be adapted accordingly.

NOTE 2 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.

NOTE 3 The following print types are used:

- requirements: in roman type;
- test specifications: in italic type;
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3. When a definition of Part 1 concerns an adjective, the adjective and the associated noun are also in bold.

A list of all parts of the IEC 60335 series, under the general title: *Household and similar electrical appliances – Safety*, can be found on the IEC website.

The following differences exist in the countries indicated below.

6.1: Class 01 appliances are allowed (Japan).

- 6.2: For appliances intended to be installed in a kitchen, an appropriate degree of protection against harmful ingress of water is required according to their height of installation (France).
- 13.2: Leakage current limits are different (Japan).
- 16.2: Leakage current limits are different (Japan).
- Clause 21: For appliances intended to be installed in a kitchen, different values of impact energy are applicable according to the height of the impact point (France).

The committee has decided that the contents of the base publication and its amendment will remain unchanged until the stability date indicated on the IEC web site under "http://webstore.iec.ch" in the data related to the specific publication. At this date, the publication will be

- reconfirmed,

NOTE 4 The attention of National Committees is drawn to the fact that equipment manufacturers and testing organizations may need a transitional period following publication of a new, amended of revised IEC publication in which to make products in accordance with the new requirements and to equip themselves for conducting new or revised tests.

It is the recommendation of the committee that the content of this publication be adopted for implementation nationally not earlier than 12 months or later than 36 months from the date of publication.

# INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules may differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another part 2 of IEC 60335, the relevant part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

# HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

# Part 2-39: Particular requirements for commercial electric multi-purpose cooking pans

# 1 Scope

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of electrically operated commercial multipurpose cooking pans not intended for household and similar use, their rated voltage being not more than 250 V for single-phase appliances connected between one phase and neutral and 480 V for other appliances. This standard also deals with pressurized appliances and appliances with pressurized parts.

NOTE 101 These appliances are used for processing food for commercial consumption, for example in kitchens of restaurants, canteens, hospitals and in commercial enterprises such as bakenes, butcheries, etc.

The electrical part of appliances making use of other forms of energy is also within the scope of this standard.

As far as is practicable, this standard deals with the common hazards presented by these types of appliances.

NOTE 102 Attention is drawn to the fact that

- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements may be necessary;
- in many countries, additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities and similar authorities.

NOTE 103 This standard does not apply to

- appliances designed exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrogive or explosive atmosphere (dust, vapour or gas);
- continuous process appliances for the continuous mass production of food;
- deep fat fryers (IEC 60335-2-37).

### 3 Terms and definitions

This clause of Part 1 is applicable except as follows.

### **3.1.4** *Addition:*

NOTE 101 The **rated power input** is the sum of the power inputs of all the individual elements in the appliance that can be on at one time; where there are several such combinations possible, that giving the highest power input is used in determining the **rated power input**.

# 3.1.9 Replacement:

# normal operation

operation of the appliance under the following conditions

The appliance is operated in accordance with the manufacturer's instructions, with no load and with the controls set to give the temperatures as set out below, the temperature being measured at the geometrical centre of the inside of the bottom face.

Stepped controls are set to the first position that gives a temperature equal to or greater than 275 °C. Cycling controls are set so that the mean value of the temperature over the cycle is  $275 \, ^{\circ}\text{C} \pm 5 \, ^{\circ}\text{C}$ . If this temperature cannot be reached, the control is set at the maximum.

Motors incorporated in the appliance are operated in the intended manner under the most severe conditions that can be expected in normal use taking into account the manufacturer's instructions.

# multi-purpose cooking pan

appliance comprising a pan, the base of which is evenly heated and that is intended principally for cooking or preparing meats, sauces, etc.

Note 1 to entry: The pan may be fixed or tilting.

Note 2 to entry: A multi-purpose cooking pan is also known as a "bratt pan".

# installation wall

special fixed construction containing supply facilities for appliances installed in conjunction with it

# 3.103

# atmospheric multi-purpose cooking pan

multi-purpose cooking pan in which the pressure within the vessel does not differ significantly from atmospheric pressure

### 3.104

# rated pressure

the maximum working pressure assigned by the manufacturer to the pressurized parts of the appliance

# 3.105

# functional surface

surface that is intentionally heated by an internal heat source and has to be not to carry out the function for which the appliance is intended

Note 1 to entry: An example is the heated sheath of a tubular heating element.

#### 3.106

# adjacent surface

surface adjacent to an functional surface and which can become not through conduction

# 4 General requirement

This clause of Part 1 is applicable.

# 5 General conditions for the tests

This clause of Part 1 is applicable except as follows.

**5.5** Addition:

The tests are carried out with the pan in the position of normal use for cooking.

## **5.10** Addition:

Appliances intended for installation in a bank of other appliances and appliances intended to be fixed to an installation wall are enclosed to obtain protection against electric shock and harmful ingress of water equivalent to that obtained when installed in accordance with the instructions provided with the appliance.

NOTE 101 Appropriate enclosures or additional appliances may be needed for test purposes.

- **5.101** Appliances are tested as **heating appliances**, even if they incorporate a motor.
- **5.102** Appliances, when assembled in combination with or incorporating other appliances, are tested in accordance with the requirements of this standard. The other appliances are operated simultaneously in accordance with the requirements of the relevant standards.

# 6 Classification

This clause of Part 1 is applicable except as follows.

# **6.1** Replacement:

Appliances shall be **class I** with respect to protection against electric shock.
