BRIEF HISTORY

The proposal to endorse the third edition of IEC Publication 335-2-8, document CLC/TC 61 (SEC) 599, was circulated under the enquiry procedure in October 1987.

This proposal was discussed during the Neusiedl meeting in May 1988 and the Brussels meeting in May 1989 when it was decided to submit a draft for EN 60335-2-8 to the voting procedure. This procedure started in October 1989.

The text of this draft was ratified by the CENELEC Technical Board on the 5th of March 1990.

A proposal to amend the test for switches was discussed during the Athens meeting in October 1985. A draft for an amendment to EN 60335-2-8 was submitted to the Unique Acceptance Procedure (UAP) in October 1989.

The text of this draft (prAmendment A) was ratified by the CENELEC Technical Board on the 11th of June 1990. It has been incorporated in EN 60335-2-8.

Instead of 10 000 cycles of operation, 5 000 cycles apply for switches incorporated in shavers and hair clippers intended for household use only.



FOREWORD

- 1) The formal decisions or agreements of the IEC on technical matters, prepared by Technical Committees on which all the National Committees having a special interest therein are represented, express, as nearly as possible, an international consensus of opinion on the subjects dealt with.
- 2) They have the form of recommendations for international use and they are accepted by the National Committees in that sense.
- 3) In order to promote international unification, the IEC expresses the wish that all National Committees should adopt the text of the IEC recommendation for their national rules in so far as national conditions will permit. Any divergence between the IEC recommendation and the corresponding national rules should, as far as possible, be clearly indicated in the latter.

iTeh STANDARD PREVIEW PREFACE (standards.iteh.ai)

This publication has been prepared by IEC Technical Committee No. 61: Safety of Household and Similar Electrical Appliances 60335-2-8:1995

It forms the third edition of IEC Publication 335-2-8 and replaces the second edition (1981) and Amendment No. 1 (1985).

The text of this publication is based on the second edition and its amendment.

This Part 2 is intended to be used in conjunction with IEC Publication 335-1. It was established on the basis of the second edition (1976) of that publication, as modified by Amendments No. 1 (1977), No. 2 (1979), No. 3 (1982), No. 4 (1984) and No. 5 (1986). Consideration may be given to future editions of or amendments to IEC Publication 335-1.

This Part 2 supplements or modifies the corresponding clauses in IEC Publication 335-1, so as to convert that publication into the IEC standard: Safety requirements for electric shavers, hair clippers and similar appliances (third edition).

Where a particular sub-clause of Part 1 is not mentioned in this Part 2, that sub-clause applies as far as is reasonable. Where this third edition states "addition", "modification" or "replacement", the relevant requirement, test specification or explanatory matter in Part 1 should be adapted accordingly.

The following differences exist in some countries:

- Class 0 and Class 0I appliances are permitted, provided they withstand higher test voltages during the electric strength test (Sub-clause 22.1).
- Power supply cords specially designed for use with electric shavers and hair clippers intended for household use only, are permitted (Sub-clause 25.6).
