Annex C (normative)

Noise test code for nailing machines

C.1 Scope

This noise test code complements EN 12545:2000 for the determination and declaration of the noise emission from nailing machines. EN 12545:2000 and this annex shall always be used jointly.

C.2 Normative references

The following referenced documents are indispensable for the application of this document For dated references, only the edition cited applies. For undated references, the latest edition of the referenced document (including any amendments) applies.

C.3 Definitions

C.3.1 Test material tps://standards.iteh.ai/catalog/standards/sist/9015ddb4-5966-4dba-886a-

A material of specified construction, incorporating, where applicable, tacks of a specified material number and length.

C.3.2 Test workpiece

A shoe heel of specified material and an insole.

C.3.3 Test cycle

A specified number of heel nailing operations within a specified noise measurement time period.

Description of machinery family

As defined in 1.1.

C.5 Determination of the 'A'-weighted sound power level

C.5.1 General

See EN 12545:2000, clause 5.

C.5.2 Measurement procedure

The machine shall be operated three times through its test cycle. The arithmetic mean of the three values of the A-weighted sound power level in dB shall be calculated, recorded and reported.

Where any microphone position is obstructed by the standing operator, that position shall be excluded from the test.

C.6 Determination of A-weighted emission sound pressure level at the workstation

C.6.1 General

See EN 12545:2000, clause 6 and the following.

C.6.2 Position of microphone

The microphone shall be located adjacent to the operator in a position as defined below, with an operator standing at the workstation on the centre line of the machine. The microphone's position is defined relative to a reference point on the ground plane on which the operator stands.

The reference point shall be at a horizontal distance of 0,4 m \pm 0,05 m in front of the machines measured in a direction parallel to the centre line of the machine and displaced a distance of 0,20 m \pm 0,02 m to the right of the centre line. **iTeh STANDARD PREVIEW**

The microphone shall be located directly above this reference point at a height of 1,60 m \pm 0,05 m. (Standards.Iten.al)

C.6.3 Measurement procedure

SIST EN 12653:2000/A1:2005

The machine shall be operated three times through its test cycle. The arithmetic mean of the three values of the A-weighted time averaged sound pressure level in dB shall be calculated, recorded and reported.

C.7 Mounting conditions

See EN 12545:2000, clause 7.

C.8 Operating conditions

- **C.8.1** The test workpiece shall consist of a high impact polystyrene ladies heel together with 5 mild steel tacks for attachment to the insole.
- **C.8.2** The nailing jack shall be that recommended by the manufacturer in the instruction handbook.
- **C.8.3** The test nailing cycle shall be:
- a) 20 nailing operations over a 3 minute noise measurement time period. This shall include the driving of 5 tacks into each test workpiece being attached, if practical. The tacks shall be at least 15 mm in length and the length shall be recorded and reported;
- b) in each case, test workpieces shall be from the same batch throughout the test cycle.
- **C.8.4** The test workpiece shall be positioned in accordance with the manufacturers instructions for the machine.

- **C.8.5** If resilient mounts are fitted, that fact shall be recorded and reported.
- **C.8.6** The machine under test shall be switched on and left to idle for a period of at least 30 minutes before the test commences.
- **C.8.7** If the specified values given in this noise test code are not fulfilled, these deviations shall be recorded and reported. Other parameters which are not specified in this noise test code shall be recorded and reported.

C.9 Measurement uncertainty

See EN 12545:2000, clause 9.

C.10 Information to be recorded

See EN 12545:2000, clause 10.

C.11 Information to be reported

See EN 12545:2000, clause 11. It is recommended that the conditions of test, material lasted or nailed, other relevant test parameters and noise data obtained be entered on a Data Sheet, an example of which is enclosed.

C.12 Declaration and verification of noise emission values
