The proposal to endorse the third edition of IEC Publication 335-2-13, document CLC/TC 61 (SEC) 555, was circulated under the enquiry procedure in May 1987.

This proposal was discussed during the Neusiedl meeting in May 1988 when it was decided to submit a draft for EN 60335-2-13 to the voting procedure. This procedure started in March 1989.

The text of this draft was ratified by the CENELEC Technical Board on the 11th of September 1989.

R The proposal to endorse amendment 1:1990 to IEC 335-2-13:1987, document CLC/TC (SEC) 738, was circulated under the enquiry procedure in June 1990.

This proposal was discussed during the Brussels meeting in November 1991 when it was decided to submit a draft for an amendment to EN 60335-2-13 to the voting procedure. This draft was circulated as prAA in March 1992 and was ratified by CENELEC as amendment A1 on the 15th of September 1992.

This amendment has been prepared by the secretariat of CENELEC technical committee TC 61.

The following dates are applicable:

- latest date of publication

of an identical national standard (dop) 1993-07-01

- date of withdrawal of

conflicting national standards (dow) 1995-07-01

For products which have complied with EN 60335-2-13:1990 before 1995-07-01, as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2000-07-01.

As a consequence of endorsing amendment 1 to IEC 335-2-13, the common modification in EN 60335-2-13 concerning subclause 30.4 is withdrawn. This procedure results in replacing this common modification by similar IEC text.

EN 60335-2-13 including this amendment shas to be used in conjunction with EN 60335-1:1988, including its amendments A2:1988, A5:1989, A6:1989, A51:1991, A52:1992 and A53:1992.

There are no special national conditions (snc) causing a deviation from this amendment.


