INTRODUCTION

Replace the fifth paragraph by the following:

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

1 Scope

Replace, in the second paragraph, "electric multifunctional shower cabinets" by "electric multifunctional shower cabinets and electric separate multifunctional shower units".

Replace the two dashed items in the fourth paragraph by the following:

- persons (including children) whose
 - physical, sensory or mental capabilities; or
 - · lack of experience and knowledge

prevents them from using the appliance safely without supervision or instruction;

- children playing with the appliance.

In Note 103, add the following dashed items before the existing first dashed item.

- instantaneous water heaters used for showering (IEC 60335-2-35);
- shower-boost pumps (IEC 60335-2-41);

3 Definitions

Add the following new definition:

3.102 iTeh STANDARD PREVIEW

separate multifunctional shower unit

multifunctional shower unit without a prefabricated shower cabinet that incorporates at least one electric function in addition to the showering function

6 Classification

6.2 In the addition, replace "Multifunctional shower cabinets" by "Multifunctional shower cabinets and separate multifunctional shower units".

7 Marking and instructions

7.1 In the addition, replace the last paragraph by the following:

If the temperature of a water or steam outlet, excluding the shower head and the water outlets when the water is not heated by the **multifunctional shower cabinet** or **separate multifunctional shower unit** itself, exceeds 60 °C, the appliance shall be marked near the outlet with the symbol IEC 60417-5041 (2002-10) or with the substance of the following:

CAUTION: Hot surface

22 Construction

22.7 Replace "Replacement:" by "Addition:"

Delete the second paragraph of the test specification.

22.33 In the addition, add the following paragraph:

Vapour is not considered to be a conductive liquid.

30 Resistance to heat and fire

Add the following subclause:

30.2 Addition:

A function that only occurs when the shower water is flowing is attended use and for that part of the appliance, 30.2.2 is applicable.

If a function is unattended use, then for that part of the appliance, 30.2.3 is applicable.
