"c) in the case of an MS, or a UA accessing an MS, the optional MS general-attribute-types and the MS general-auto-action-types for which conformance is claimed."

Change the full stop to a semicolon in the end of bullet a) and add a new bullet as follows:

"b) in the case of an MS, or a UA accessing an MS, support the MS abstract-service definition in ISO/IEC 10021-5 as well as the general-attribute-types classified as mandatory in Table 1 of ISO/IEC 10021-5."
