INTRODUCTION

Replace the fifth paragraph by the following:

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

1 Scope

Replace the two dashed items in the fourth paragraph by the following:

- persons (including children) whose
 - · physical, sensory or mental capabilities; or
 - lack of experience and knowledge

prevents them from using the appliance safely without supervision or instruction;

- children playing with the appliance.

24 Components

24.101 Add the following to the first paragraph of the requirement:

This requirement is not applicable if the appliance fulfils the tests of 19.3 with all thermal controls that limit the temperature of the heat-accumulating core short-circuited.

Add the following to the test specification:

When carrying out the tests of 19.3 with all thermal controls that limit the temperature of the heat-accumulating core short-circuited, the charging period is terminated after thermal stabilisation of the temperature rise of the top surface of the appliance.

NOTE During the tests of 19.3 with all thermal controls that limit the temperature of the heat-accumulating core short-circuited, failure of one or more heating elements is allowed.
