INTRODUCTION

Replace the fifth paragraph by the following:

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

Replace the two dashed items in the fourth paragraph by the following:

- persons (including children) whose
 - physical, sensory or mental capabilities; or
 - · lack of experience and knowledge

prevents them from using the appliance safely without supervision or instruction;

children playing with the appliance.

7.1 In the addition, replace "5574 of IEC 60417-1" by "IEC 60417-5574 (2002-10)" and "5582 of IEC 60417-1" by "IEC 60417-5582 (2002-10)".

- **7.12** In the addition, replace "5574 or 5582 of IEC 60417-1" by "IEC 60417-5574 (2002-10) or symbol IEC 60417-5582 (2002-10)".
- 7.14 In the addition, replace the text by the following:

The height of symbol IEC 60417-5574 (2002-10) and symbol IEC 60417-5582 (2002-10) shall be at least 5 mm.

25.5 Add the following:

Type X attachments are not allowed on appliances with an IP classification exceeding IPX4.

25.7 Add the following to the last paragraph of the addition:

This requirement is not applicable to the **supply cord** on the battery charging unit for shavers for household use only.
