NOTE The attention of National Committees is drawn to the fact that equipment manufacturers and testing organizations may need a transitional period following publication of a new, amended or revised IEC publication in which to make products in accordance with the new requirements and to equip themselves for conducting new or revised tests.

#### INTRODUCTION

Replace the fifth paragraph by the following:

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

Replace the two dashed items in the fourth paragraph by the following:

  - physical, sensory or mental capabilities; or

- children playing with the appliance.

Replace in Note 102 the fifth dashed item by the following:

battery chargers for emergency lighting (IEC 60598-2-22).

#### 7 Marking and instructions

- **7.1** Replace the fourth dashed item by the following:
- the polarity of the output terminals. The positive terminal shall be indicated by symbol IEC 60417-5005 (2002-10) and the negative terminal by symbol IEC 60417-5006 (2002-10);

Add the following subclause:

#### 7.6 Addition:



[Symbol IEC 60417-5005 (2002-10)] plus; positive polarity

[Symbol IEC 60417-5006 (2002-10)] minus; negative polarity
