This document (EN 1176-2:1998/A1:2003) has been prepared by Technical Committee CEN/TC 136 "Sports, playground and other recreational equipment", the secretariat of which is held by DIN.

This Amendment to the European Standard EN 1176-2:1998 shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by October 2003, and conflicting national standards shall be withdrawn at the latest by October 2003.

The purpose of Amendment 1 to EN 1176-2:1998 is to modify clause 4.11.

With resolution 165, CEN/TC 136 agreed to an Amendment 1 to EN 1176-2:1998 using the UAP procedure of 4 months.
