This amendment to the European Standard EN 60745-2-2:2003 was prepared by the Technical Committee CENELEC TC 116 (former TC 61F), Safety of hand-held motor-operated electric tools. It was drafted to extend Annex ZZ to include the new MD 2006/42/EC.

The text of the draft was submitted to the formal vote (as FprAC) and was approved by CENELEC as amendment A12 to EN 60745-2-2:2003 on 2009-11-17.

The following dates were fixed:

- latest date by which the amendment has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 2010-06-01
- latest date by which the national standards conflicting with the amendment have to be withdrawn (dow) 2010-06-01

This European Standard has been prepared under a mandate given to CENELEC by the European Commission and the European Free Trade Association and covers essential requirements of EC Directive 98/37/EC (Machinery Directive), amended by Directive 98/79/EC, and of EC Directive 2006/42/EC.
