Foreword

This amendment to the European Standard EN 60745-2-5:2007 was prepared by the Technical Committee CENELEC TC 116 (former TC 61F), Safety of hand-held motor-operated electric tools.

It was drafted to bring the existing standard in line with the new MD (modification Subclause 6.2.7.2 and Figure Z101) and to extend Annex ZZ to include the new MD 2006/42/EC.

The text of the draft was submitted to the formal vote (as FprAB) and was approved by CENELEC as amendment A11 to EN 60745-2-5:2007 on 2009-11-17.






Figure Z101 - Positions of transducers for circular saws
