Introduction

This Amendment has been prepared by CEN/TC 49 in order to ensure that the testing is as close as possible to that which applies to appliances having a single hotplate burner with a heat input in excess of 4,2 kW (EN 30-2-1:1998/A1) and so as not to alter the testing of appliances that do not have hotplate burners with heat inputs in excess of 4,2 kW.

This Amendment is based on the text of EN 30-2-1 as amended by its A1.
