Amend 7.2, Table 1:

For Copper in column 2, line 6 - change ST5 to 1909:2004/A1:2005

In column 1 lines 5 and 6 of Table 1, add an asterisk to read  $15^2$  and  $22^*$  49cd-b61a-

Add a new line at the end of Table 1 with the following:

"\* For caravan holiday homes the above values for wall thickness are recommended but it may be acceptable in certain countries to use a different wall thickness in accordance with EN 1057."

## 10 Modification to 7.4

1st paragraph: replace "where screw thread fittings and steel pipe are used" by "of threaded fitting, see e) from Figure 3 made of steel pipe".

2<sup>nd</sup> paragraph: "...used on compression fittings" replace by "...all other fittings".

## 11 Modification to 7.5 Shut off valves

The last sentence shall read: "...If control handles operate by turning, the "closed" positions shall be at 90° in either direction from the fully "open" position."

## 12 Modification to 8.6

1st sentence shall read: "Where LPG pipes are installed near electric supply lines, contact with the electricity supply lines shall be avoided by spacing, insulation and sheathing or other means."

Last sentence is unchanged and shall read: "If confusion with other services is possible the ..."

## 13 Modification to 8.7 Fixing

Amend text as follows:

"Steel or stainless steel pipes shall be secured at intervals not exceeding 1000 mm. Copper pipes shall be secured at intervals not exceeding 500 mm, in caravan holiday homes 1 000 mm. If a metal clamp..."

## 14 Modification to 10.2

Shall read: "...safe removal of combustion products;" Delete: "and avoidance of accumulation of unburned gases;"

## 15 Modification to 10.4.2

In line 3, change: "... products of production..." to "...products of combustion..."

## 16 Modification to 11.2 Flue terminals

3<sup>rd</sup> paragraph: change: ...(see Annex A of EN 624:2000) ... to (see annex B)
