Text of A11 to EN 60745-1:2009

19 Mechanical hazards

19.1 **Add** after the 2nd paragraph:

For fixed guards that are to be removed at the place of use as part of the routine maintenance procedure, as described in the instruction manual, the fastenings shall remain attached to the guard or to the tool.

NOTE 1 Replacement of brushes is not considered as part of the routine maintenance.

Replace 'NOTE 1' and 'NOTE 2' by 'NOTE 2' and 'NOTE 3' respectively.
