Page 4

After subclause 5.4 add the following subclause 5.5.

5.5 Marking

Marking, if envisaged, should be outside the fitting length l_1 .

If the marking is applied within the fitting length l_1 , the outside diameter of the marking shall not exceed the effective diameter of the shank.

Marking shall be resistant to disinfection, cleaning and sterilization according to the manufacturer's instructions.
