1 Scope

This standard specifies a method of visual inspection for circuit breakers.

It shall be used together with EN 3841-100.

3 Method

The visual inspection shall be performed without magnification.

It concerns:

- general appearance (surface finish, colour, assembly);
- conformity and quality of markings and inscriptions;
- undamaged condition of calibration seal;
- after climatic environmental tests, inspection of all parts which may show corrosion or poor legibility of the markings.
