This document (EN 12983-1:2000/A1:2004) has been prepared by Technical Committee CEN/TC 194 "Utensils in contact with food", the secretariat of which is held by BSI.

This Amendment to the European Standard EN 12983-1 shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by June 2005, and conflicting national standards shall be withdrawn at the latest by June 2005.

*Page 4, Clause 2*

Insert the following in the list of normative references:

"EN 2536:1995, *Aerospace series – Hard anodizing of aluminium alloys*".

*Page 10, subclause 9.2*

Add the following paragraph at the end of the subclause:

"This requirement is applicable only when the product is claimed as being for use on a solid plate or on a glass ceramic hob either with radiant or halogen heaters. This requirement does not apply to products claimed as being only for use on a gas or radiant ring."

*Page 28, Figure M.1*

In the key, item 4, delete "Surface: hard anodised, black 682 Coating thickness 25 µm" and insert the following:

"Surface: hard anodized, black 682 (in accordance with EN 2536:1995), coating thickness 25 µm".
