Replace the fifth paragraph by the following:

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For

example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

- shark deterrent devices that are carried by the user.

Replace the title of Clause 3 but not the clause number, by the following:

Terms and definitions in the STANDARD PREVIEW

3.103 Add the following new note and renumber the existing note as Note 1.

NOTE 2 This does not preclude the return **electrode** being held by the user.

- **7.1** In the fourth dashed item, replace "symbol 1641 of ISO 7000" by "symbol ISO 7000-0790 (2004-01)".
- 7.6 Delete the "dangerous voltage" symbol and associated text.

Replace "[symbol 5017 of IEC 60417]" by "[symbol IEC 60417-5017 (2006-08)]".

7.8 Replace the text of the addition by the following:

For **battery-operated electric fishing machines**, the supply terminals for connection of the battery shall be clearly indicated by symbol IEC 60417-5005 (2002-10) if of positive polarity, and by symbol IEC 60417-5006 (2002-10) if of negative polarity, unless the polarity is irrelevant.

7.12 Replace the last paragraph by the following:

If symbol IEC 60417-5017 (2006-08), symbol IEC 60417-5036 (2002-10) or symbol ISO 7000-0790 (2004-01) are marked on the appliance, their meaning shall be explained.

7.15 Replace the subclause number by **7.14**.

Replace the last paragraph by the following:

Symbol IEC 60417-5017 (2006-08), symbol IEC 60417-5036 (2002-10) and symbol ISO 7000-0790 (2004-01) shall have a height of at least 25 mm.
