Add the following before the last paragraph:

The instructions for **hobs** shall include the substance of the following:

WARNING: Use only hob guards designed by the manufacturer of the cooking appliance or indicated by the manufacturer of the appliance in the instructions for use as suitable or hob guards incorporated in the appliance. The use of inappropriate guards can cause accidents.

21 Mechanical strength

In the amendment to 21.102, substitute the following text:

*In the third paragraph of the test specification, replace “The vessel” by “For **induction hob elements**, the vessel”*

by the following text:

*In the third paragraph of the test specification, replace “The vessel” by “For **hob elements**, other than **induction wok elements**, the vessel”.*
