The following modifications shall be included in the text of EN 1433:2002:

Subclause 7.10.1.2

Table 9 shall be amended by adding a footnote ^a to the length ≤ 170 mm as shown below:

NOTE In pedestrian streets and pedestrian areas the slot width can be reduced to 5 mm at the specifier's discretion.			
^a A deviation from this requirement is permitted for slot units and kerb units designed for places of installation where traffic by bicycles is prohibited. The Specifier is responsible for ensuring that the product is safe to use in the area intended, where such deviation from these requirements is considered.
