This document (EN 206-1:2000/A2:2005) has been prepared by Technical Committee CEN/TC 104 "Concrete and related products", the secretariat of which is held by DIN.

This Amendment to the European Standard EN 206-1:2000 shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by December 2005, and conflicting national standards shall be withdrawn at the latest by December 2005.

This document covers matters for which the need for amendments or corrections to EN 206-1: 2000-12 has been identified by CEN/TC 104 "Concrete and related products"

The numbering and headlines in the following correspond to the those in EN 206-1 for which the amendments and corrections apply.

## 1 Modifications to 4.1

### 4.1 Exposure clauses related to environmental actions

A third paragraph has to be added, reading as follows:

*For a given structural component, different concrete surfaces may be subject to different environmental actions.*

## 2 Modifications to 5.4.1

### 5.4.1 Consistence

Second paragraph has to be read:

*Where the consistence is to be determined, the specified requirement applies at the time of use of the concrete or in the case of ready-mixed concrete, at the time of delivery.*
