COMMON MODIFICATIONS

1 Scope

Replace the fourth paragraph by the following:

This European Standard deals with the reasonably foreseeable hazards presented by appliances and machines that are encountered by all persons.

However, in general, it does not take into account

- children playing with the appliance,
- the use of the appliance by very young children without supervision.

It is recognized that very vulnerable people may have needs beyond the level addressed in this standard.

7 Marking and instructions

7.12 Modification:

In the fourth paragraph of Part 1, replace "from 8 years and above" by "from 3 years and above".

In Part 2, delete the modification "The instructions concerning persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience and knowledge and children playing with the appliance are not applicable."

Relationship between this European Standard and the safety objectives of Directive 2014/35/EU [2014 OJ L96] aimed to be covered

This European Standard has been prepared under a Commission's standardization request relating to harmonized standards in the field of the Low Voltage Directive, M/511, to provide one voluntary means of conforming to safety objectives of Directive 2014/35/EU of the European Parliament and of the Council of 26 February 2014 on the harmonization of the laws of the Member States relating to the making available on the market of electrical equipment designed for use within certain voltage limits [2014 OJ L96].

Once this standard is cited in the Official Journal of the European Union under that Directive, compliance with the normative clauses of this standard given in Table ZZA.1 confers, within the limits of the scope of this standard, a presumption of conformity with the corresponding safety objectives of that Directive, and associated EFTA regulations.

Compliance with this Part 2 when used together with the Part 1 provides one means of conformity with the safety objectives.

This International Standard deals with the safety of electric toilet appliances having a rated voltage being not more than 250 V, in which excrement is stored, dried or destructed or which wash or dry parts of the human body.

Replace the existing Note 101 by the following:

NOTE 101 Examples of such electric toilets are the following and they can be used to process garbage such as paper and food waste.

- mouldering toilets;
- package toilets;
- freezing toilets;
- vacuum toilets.

In the 5th dash of Note 102, replace "shower units" by "spray seats".

In Note 102, add the following new dashed item:

spray seats.

3 Definitions

Replace the title of Clause 3 but not the clause number, by the following:

Terms and definitionseh STANDARD PREVIEW

3.1.9 Add the following as new third and fourth paragraphs of the term definition:

For **spray seats**, if the cycle is not automatically terminated, the appliance is operated for 30 s. If the cycle is automatically terminated, the appliance is operated for 30 s or automatic operation time, whichever is shorter.

If warm air is provided for drying and if the cycle is not automatically terminated, the appliance is operated for 1 min. If the cycle is automatically terminated, the appliance is operated for 1 min or automatically terminating time, whichever is shorter.

Replace "Shower units" by "Spray seats" in the existing seventh paragraph of the term definition.

3.105 Replace the term and term definition by the following:

spray seat

appliance that sprays water for cleaning parts of the human body

NOTE 1 **Spray seats** can have functions such as heating the seat, drying, deodorizing or automatically opening/closing the seat and the bowl cover.

NOTE 2 Spray seats can be integrated with a toilet.
