Foreword

This European Standard (EN 492:2004/A1:2005) has been prepared by Technical Committee CEN/TC 128 "Roof covering products for discontinuous laying and products for wall cladding", the secretariat of which is held by IBN/BIN.

This Amendment to the European Standard EN 492:2004 shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by February 2006, and conflicting national standards shall be withdrawn at the latest by February 2006.

This European Standard has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s).

This amendment takes into account Directive 76/769/EEC on dangerous substances and preparations, prohibiting from January 1, 2005, the introduction of new applications of asbestos cement materials.

"Attention is drawn to the need for observance of EU and/or EFTA Directives transposed into national legal requirements restricting the use of certain materials and to the related marking and labelling requirements."

Modify the 2nd paragraph of 5.1.1 to read:

"This European Standard covers fibre-reinforced cement slates and fittings of type NT (Non-asbestos Technology)."

2.2 Modification 2

Delete 5.5.3.1 and the subtitle 5.5.3.2 to read:

"5.5.3 Release of dangerous substances

For products containing substance(s) defined in Council Directive 76/769/EEC, the content shall be declared by the manufacturer. This applies to substances contained in the original formulation or created during the manufacturing process. In addition see Annex ZA."

5 Deletion of Annex ZB

Delete Annex ZB entirely.
